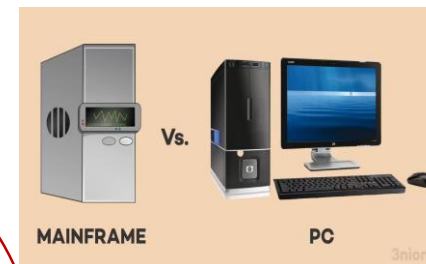

- Potentials and needs for **digital technology** are present to enhance Agricultural Productivity.
- Rapid digitalization (internet and mobile) took place in last decade
- Technology needs to be **adopted to local context**
- **Public interventions, Public-Private collaboration and good coordination are needed for:**
 - Capacity building, infrastructure and creating good business eco systems and finances. Digital agriculture is progressing towards “bundling up” different services with a platform (along the value chain).
- Newly presented Japanese scheme, **Agriculture Innovation Platform in Africa (AIPA)** be a solution?
 - Emphasis on **digital solution, building critical mass** of JPN firms, targeting areas where services are needed
